Dear Chet Mottershead:

This letter is being written to inform you that Lee and Chatham Counties have requested to join Capital Area Workforce Development Board's (CAWD) Local Area which currently includes Wake and Johnston Counties. All four-county chief elected officials and Capital Area Workforce Development Board have agreed to this transition which will take place July 1, 2022.

CAWD is requesting, from DWS, the transfer of Program and Fiscal Agent responsibility from Triangle South Workforce Development Board to Capital Area Workforce Development Board effective July 1, 2022. We are currently working with Triangle South Workforce Development Board to identify equipment inventory, compare processes, conduct file reviews, and other activities to ensure a smooth transition.

Triangle South currently uses the same youth service provider for their Title I youth program, so this will be an easy transition for staff and customers. The current youth service provider's 2021 Triangle South contract ends June 30, 2022, so we will issue a new CAWD youth contract with them effective July 1, 2022. Triangle South's current Adult Title I service provider's contract ends June 30, 2022. Capital Area will transition Lee and Chatham Adult Title I services to our current Adult Service Provider effective July 1, 2022. Our current Adult Title I service provider has agreed to hire all adult service provider staff serving Lee and Chatham counties without them having to go through a formal recruitment process. We will know well before July 1 whether the current service provider's staff wish to join the CAWD's current Adult Title I service provider. If they are not interested in joining our current provider, our provider will recruit for new staff with a start date of July 1, 2022.

Since this transition will not take place until July 1, 2022, we will update relevant documents (by-laws, consortium agreement, one stop MOU, infrastructure agreement) during the normal schedule for PY22.
