The transfer of Lee and Chatham counties from Triangle South WDB to Capital Area WDB is the result of a planned dissolution of the Triangle South WDB.

1. Impact on service delivery in the proposed reorganized Local Area;

The major impact is that we now have 4 counties versus two counties to serve with workforce development services. Both of CAWD's current counties (Wake and Johnston) each have a level 1 NCWorks Career Center and a NCWorks NextGen Center. For the new counties, Lee and Chatham, youth and adult services are served out of the NCWorks Career Centers. In reviewing the traffic for the Lee and Chatham County centers, traffic has really trended down for the last few years as indicated with the Wagner Peyser enrollments on "Triangle South Enrollment WIOA and WP attachment". Our plan is to designate the centers in these two counties as level 2 centers. CAWD uses one provider for adult and another provider for youth. Since we are not in an RFP year, we have coordinated with our existing providers to extend services to Lee and Chatham counties. Fortunately, Triangle South uses the same youth service provider, so the transition will be easier. For our CAWD adult provider, they are working with our Triangle South's adult provider and have agreed to absorb

staff without the usual interview process. CAWD staff and providers are reviewing all files prior to July 1, 2022 to ensure we are inheriting compliant files. The numbers of individuals enrolled in WIOA has also trended down in Lee and Chatham counties for the last 6 years. (see Triangle South Enrollment WIOA and WP). We assume this is due to the very low funding levels for this area.

2. Costs and benefits of a potential reorganization including, availability of educational and training providers (such as institutions of higher education and career and technical education schools in the area), needs and services related to the business and employer community and other community-based needs;

Currently the NCWorks Career Center in Chatham County is on the campus of Central Carolina Community College, and they do not charge rent. They have agreed to host the center for program year 2022, but CAWD will need to find a new location to host the center starting PY23. Our goal will be to locate in another no cost center such as local government (library, social service office) or community-based organization. We also plan to expand our virtual services offerings to the area. For Lee County, the NCWorks Career Center is located in a DWS leased facility. The lease on that facility ends in the fall of 2023 and our plan would be to not renew that lease but also find a no cost location and/or expand our virtual services to that area.

Central Carolina Community College provides post-secondary education services to both counties. Our plan is to partner with them as we do with the current community colleges in our region.

For business services, our Business Engagement Director will now include these counties in her engagement efforts. This includes partnering with the local economic development entities and other business organizations in the counties. We will also hire one business consultant that will split his/her time between the NCWorks Career Center in Lee and Chatham Counties.

3. Consistency with natural labor market areas and commuting patterns;

Lee and Chatham Counties have a shared labor market with CAWD and all four counties are part of the Triangle J Council of Governments. The role of the council of Governments (COGs) is to provide creative regional solutions to relevant and emerging issues for the region while providing a standard of excellence in the delivery of federal, state and regional services for member counties. Lee County Commuting patterns with Wake County: Commuters to Wake County 5,501 and Commuters from Wake County 2,428. For Chatham County commuters: Commuters to Wake County 3,757; Commuters from Wake County 1,726.

4. Consistency with regional economic development areas;

Both Lee and Chatham Counties are a part of the Triangle J Council of Governments as is Wake and Johnston Counties. As well, all four counties are in the same prosperity zone.

5.
