### Perdue, Crisco welcome Hatteras yachts

Gov. Bev Perdue and N.C. Dept. of Commerce Sec. Keith Crisco were among the state and local leaders on hand Aug. 6 to celebrate Brunswick Corp.'s announcement that it will consolidate its Hatteras- and Cabo-brand yacht manufacturing operations at its New Bern plant.

"Hatteras Yachts, as you all know, has been a staple of New Bern's economy, and the region's economy, quite frankly, since (1959)," Perdue said. "It was here since I moved here in the late '70s, and we've been through great times when nobody around the world could buy yachts fast enough to hard times in other recessions, but never as hard as these past three years when the global economy was stressed."

"Bringing our brands under one physical roof will allow us to fully leverage our technological and operational advantages, better serve our dealers and customers, reduce fixed costs and more effectively use our available manufacturing capacity," explained Hatteras President James R. # Caterpillar to bring 485 jobs to Lee County

On Aug. 5, Gov. Bev Perdue announced that Caterpillar Inc., the largest maker of construction and mining equipment, diesel and natural gas engines, and industrial gas turbines in the world, will expand its manufacturing facilities in Lee County.

The company plans to create 325 jobs over the next four years. In addition, a company supplier is expected to locate 160 jobs in North Carolina as part of the expansion, bringing the total to 485 jobs. Caterpillar will invest \$28.3 million as part of the project in Sanford, which was made possible in part by state grants from the Job Development Investment Grant program and One North Carolina Fund. The N.C. Dept. of Commerce's Jamie Vaughn was the developer on the project.

This is the second job announcement for Caterpillar in one week. On July 30 the company revealed it will expand its manufacturing facilities in Winston-Salem, investing \$426 million and creating 392 jobs. Read more.

Gov. Bev Perdue on Aug. 10 announced that Medicago [Med-ih-CAH-go] USA Inc. will locate a new vaccine production facility in Durham. The company is a wholly owned subsidiary of Medicago, Inc., a publicly traded

### Ethan Allen expansion to bring 90 jobs to McDowell County

Gov. Bev Perdue on Aug. 4 announced that Ethan Allen Operations Inc., a manufacturer of Ethan Allen Interiors, will expand in Old Fort. The company plans to create 90 jobs and invest \$250,000 to expand its production capacity. The project was made possible in part by a \$270,000 grant from the One North Carolina Fund. The N.C. Dept. of Commerce's Bill Payne was the developer on the project.

Ethan Allen, established in 1932, is an American brand with global reach, manufacturing about 70 percent of its products in seven North American plants. The company's Old Fort plant manufactures high quality, solid wood case goods furniture such as dining and bedrooms sets for its North American and international design centers. The company also manufactures upholstery furniture in Maiden and has about 1,300 employees in North Carolina. Read more.

### Norandal plant in Rowan County to get 25 jobs

Gov. Bev Perdue on Aug. 6 announced that Noranda Aluminum Holding Corp will expand its Norandal USA plant in Salisbury. The company plans to create 25 jobs and invest \$7 million. The project was made possible in part by a \$108,000 grant from the One North Carolina Fund. The N.C. Dept. of Commerce's Uconda Dunn was the developer on this project.

"This is great news for Rowan County -- and the second time this week we have announced expansions there," said Gov. Perdue. "Companies know they have a workforce they can count on and a highly motivated team of economic development partners, as well as a state that will support their growth and success."

Norandal USA, a wholly owned subsidiary of Noranda, includes the company's rolling-mills business. Rolling mills, such as the one in Salisbury, take aluminum and roll it into metal sheets and foil for commercial use. The grant-supported expansion will allow the company to update machinery and increase capacity.

Salaries will vary by job function, but the annual average wage for the new jobs will be \$43,097 not including benefits. The Rowan County average annual wage is \$35,048. The company currently employs 163 in Salisbury.

### **Building materials maker to bring 25** jobs to Rowan County

On Aug. 3, Gov. Bev Perdue announced that Boral Composites Inc., a sister company to Boral Bricks in East Spencer, plans to open a plant to produce a new green product line for homebuilding. The company plans to create 25 jobs and invest \$12.8 million. The project was made possible in part by a \$50,000 grant from the One North Carolina Fund. The N.C. Dept. of Commerce's Uconda Dunn was the developer on this project.

BCI is an independent, wholly owned subsidiary of Boral USA,

company based in Quebec, Canada. The firm plans to create 85 jobs in Research Triangle Park. The project was made possible in part by a \$128,000 grant from the One North Carolina Fund. The N.C. Dept. of Commerce's Garrett Wyckoff was the developer on this project.

The Defense Advanced Research Projects Agency (DARPA) has awarded Medicago a \$21 million research grant to improve the process of large-quantity H1N1 vaccine production using plant-based technology. The company is currently using tobacco leaves to produce pandemic and seasonal influenza vaccines. Medicago's project with DARPA will lead to a total investment of more than \$32 million in Research Triangle Park.

# Three N.C. counties recognize Canadian manufacturer at joint event

During a ceremony at the City-County Chambers in Lenoir on July 31, Magna Exteriors and Interiors was welcomed by local and state officials, including N.C. Dept. of Commerce Deputy Sec. Dale Carroll.

"It's an indication that the economy is beginning to pick up," Carroll said. "Manufacturing is still an important part of the North Carolina economy."

Headquartered in Toronto, Canada, Magna is the largest automotive supplier in North America. The publicly traded company has been seeking to diversify into other areas and acquired the assets of auto parts company Meridian last year. The company will have operations in Caldwell, Catawba and Rowan counties, with the Lenoir location focusing on manufacturing parts for clients such as Ford, General Motors, Volvo, Trane and Aquatic Industries.

The company has received approval from a jobs incentive grant through Commerce to create 327 new positions among the three locations, including 134 at the Lenoir location. In addition, Caldwell County has approved providing \$2,000 per new job created up to 181 posts, while Lenoir has agreed to grant back 75 percent of created ad valorem tax base for a period of four years. ### Programs to provide \$18 million for N.C. farmers

Gov. Beverly Perdue on Aug. 2 announced an \$18.4 million package of programs to help North Carolina farmers rebound from the recession.

Under the Family Farm Innovation Fund, five state and federal programs will help farmers lower energy costs, launch renewable energy projects, implement value-added production and develop other sources of farm income. Over the next year, the program is expected to provide grants for up to 1,500 farm projects and energy efficiency training for an additional 2,400 farmers. Read more.

# Perdue announces grants for green workforce training

Gov. Bev Perdue, U.S. Rep. Heath Shuler, and Appalachian Regional Commission Federal Co-Chair Earl F. Gohl announced a \$300,000 grant on Aug. 5 to the Southwestern N.C. Planning & Economic Development Commission to assist three Appalachian community colleges in developing a green workforce training program.

The announcement of the grant was made during a press conference convened by the ARC at Western Carolina University. It will be matched by another \$494,000 in local funding for a total of \$794,000 to develop the training program. Some 400 students are anticipated to enroll in the program at Haywood, Southwestern, and Tri-County community colleges.

### RTI to develop registry for nanomaterials

Scientists at RTI International in Research Triangle Park will develop a registry for nanomaterials as part of a new contract from the National Institutes of Health's National Heart, Lung and Blood Institute.

Under terms of the federally funded three-year contract, worth \$2,889,367, researchers at RTI will establish a web-based registry that will provide curated information on the biological and environmental interactions of well-characterized nanomaterials.

The registry is being designed to facilitate data validation and data quality improvement of nanomaterials; enhance the development of new models, assays, standards, and manufacturing methods; and accelerate the translation of new nanomaterials for biomedical and environmental applications. ### Perdue announces \$83M to expand broadband access

Gov. Bev Perdue on Aug. 4 announced that North Carolina has received \$83 million in five federal recovery grants to extend broadband connectivity in rural parts of North Carolina. These funds will create jobs upfront, and help spur economic development in these areas through expanded access to high-speed Internet.

The grants are five of 126 federal Recovery Act broadband projects recently announced as part of a second round of funding. In January, as part of first round awards, MCNC received \$28.2 million to build a 480-mile fiber-optic network for the North Carolina Research and Education Network (NCREN). In July as part of round two awards, \$30 million in grants were awarded to expand broadband access in western North Carolina. Read more.
