

## **HUBER+SUHNER** to **Relocate North American Headquarters** to North Carolina

Governor Pat McCrory and N.C. Commerce Secretary Sharon Decker announced on Oct. 25 that HUBER+SUHNER, a manufacturer of components and system solutions for electrical and optical transportation of data and energy, will locate its North American headquarters in Mecklenburg County. The company plans to create 50 jobs and invest more than \$3 million in its new Charlotte facility. The N.C. Department of Commerce's Ron Leitch was the developer on this project.

"North Carolina and the Charlotte region have become very desirable for companies to locate their U.S. headquarters," said McCrory. "Our business climate, access to a talented workforce and outstanding quality of life continue to pay dividends as we recruit new companies and encourage existing companies to expand."

HUBER+SUHNER, a Switzerland-based worldwide company, serves customers in the communication, transportation and industrial markets with cables, connectors, cable systems, antennas and other passive components, relying on its expertise in radio frequency, fiber optics and low frequency technologies. The company operates its major North American manufacturing facilities in Mexico and New Jersey.

"We're delighted about HUBER+SUHNER joining the ranks of companies that call North Carolina home," said Decker. "Their footprint in the telecommunications and industrial sector fits perfectly in the Charlotte region."

"We are excited to move to North Carolina and call Charlotte our home. We have been very impressed by the available talent, friendly tax climate and ideal geographical location to operate our business," said HUBER+SUHNER North America President & General Manager Andrew Hollywood.

The Charlotte operations of HUBER+SUHNER will include sales, distribution and management. The company expects to have the new U.S. headquarters fully operational by the end of 2014.

## **Decker Joins State's Metro Regions in Showcasing North Carolina**

N.C. Commerce Secretary Sharon Decker is working with presidents of the state's three urban regional development partnerships in a concerted push to promote North Carolina to national location advisors and business media. Their initial plans call for visits with site-selection consultants and journalists in New York City in mid-November.

"It's exciting to see our largest economic regions coming together, and I'm eager to collaborate in their efforts," Decker said. "The high-wage jobs and high-dollar investments that power our major metro areas are the fuel for North Carolina's overall economic revival - moving the needle for us in the near-term as we reconsider the longer-range infrastructure and workforce needs of our state."

Plans call for the Secretary's personal participation with the presidents of the Charlotte Regional Partnership, Piedmont Triad Partnership and Research Triangle Regional Partnership in a series of outreach events in coming months. The four will promote business opportunities in North Carolina, specifically how economic assets along the "crescent" that connects Charlotte, the Triad and Raleigh-Durham can support the needs of growing, cutting-edge firms.

The initiative marks the first time the three regional partnerships have joined forces to cross-sell assets, share resources and speak with a single voice for the state's urban centers. "As state government reorganizes its programs and re-focuses resources, the timing was ideal for the urban regions to step forward and provide visible leadership," said David Powell, president and CEO of the Piedmont Triad Partnership, based in Greensboro. The three business-driven organizations collectively have over six decades of corporate recruitment experience, a leadership corps that includes top executives from some of the state's largest employers and financial resources raised from a long roster of private donors. "By coming together and working with Secretary Decker, we make a compelling statement about North Carolina's ability to compete for - and win - game-changing projects," Powell said.

Taken together, the three regions encompass about 65 percent of the state's total population. In fact, one of three new residents arriving in North Carolina between 2000 and 2010 live in either Wake County or Mecklenburg County, according to the North Carolina DataNet. Measured in economic power, North Carolina largest cities are formidable. Wake County's median worker earnings in 2011 topped \$84,550, according to the N.C. Department of Commerce, a figure that was more than three times greater than that earned by the average employee statewide. "Economically, we have returned to the age of city-states," said Research Triangle Regional Partnership President and CEO Charles Hayes. "High concentrations of people and businesses, along with urban amenities such as commercial airports and research universities, are today the simplest predictors of job-growth and prosperity," he said.

Basic reforms to North Carolina's economic development structure and strategy during the past year may have prompted some site-selection consultants to take a wait-and-see approach to bringing clients and projects to the Tar Heel State. "It's our job to ensure that site advisors and corporate decision makers are well aware of the state's diverse assets," said Charlotte Regional Partnership President and CEO

The construction of the quality laboratory was made possible, in part, by local and state incentives, including a grant from the <a href="One-North Carolina Fund">One-North Carolina Fund</a>, which provides financial assistance, through local governments, to attract business projects that will stimulate economic activity and create new jobs in the state. Since the grant was awarded, Hospira has added nearly 200 jobs to the Rocky Mount plant overall.

"We have a very strong and talented workforce that will provide Hospira with skilled workers that they are looking for. #### Division of Employment Security Receives Favorable Marks in Recent Audits

The N.C. Department of Commerce recently received positive results from three separate audits of the Division of Employment Security. The Division was audited by the U.S. Department of Labor, the Social Security Administration and the Internal Revenue Service

"We're committed to making changes that will benefit the unemployment insurance system," said Assistant Secretary of Employment Security Dale Folwell. "Positive audit reports show that we're on the right track in those areas. However, we remain committed to quality customer service and improving all aspects of the unemployment insurance program."

In late March, USDOL conducted an audit to evaluate operational control of funds within the Unemployment Insurance program. Additional review objectives included reviewing the DES Office of Internal Audit practices, operational procedures for addressing internal security incidents and violations, identifying current or former agency employees receiving unemployment, evaluating computer security and data processing systems, and reviewing risk analysis processes.

"USDOL stated that no findings were identified during the review," said Folwell. USDOL also recognized the DES Office of Internal Audit business practices as a "Best Practice" for other states to follow. Folwell

Ronnie Bryant. "We also want there to be no question that we will do everything possible on the local, regional and state levels to help businesses succeed in North Carolina." Bryant says sitting down face-to-face with key site-selection professionals and business journalists is the most effective strategy for conveying North Carolina's brand message around the world. "And that message is, that we're still the best state in the country for business -- period," Bryant said.

Bryant, Decker, Hayes and Powell will hold the first of their consultant and media meetings in New York City on Nov. 14.

Kent Holliday, a New York City-based location advisor with Cresa Consulting Services & Portfolio Strategies, says face-to-face outreach is the ideal way economic developers can promote their communities, regions and states. "For me, getting together with people is the best way for them to deliver their message," says Holliday, who works primarily with technology companies seeking business locations. His clients lean toward urban locations because that's where most technology workers prefer to be. "They come from cities and like urban lifestyles: density, cultural institutions, diversity, and a high level of energy," he says. Holliday, who has worked in real estate planning since 2000, says it is uncommon for a state and all of its major cities to work together on focused outreach. "Usually it's one or the other," he says. "This kind of approach is unique."

## **QVC Unveils Second Solar Farm in North Carolina**

QVC Inc. (NASDAQ: LINTA, LINTB) announced on Oct. 22 the completion of a solar farm comprising 11,564 panels on 11 acres at the Rocky Mount Distribution Center owned by QVC Rocky Mount Inc.

Now generating 5.8 million kilowatt-hours per year, this latest addition brings the combined total number of panels at the site to 17,244 over 18 acres. The first field of 5,680 solar panels on seven acres of land was completed in 2008.

"QVC will conserve enough kilowatt-hours of energy to reduce CO2 emissions that are equivalent to 458,766 gallons of gasoline," said QVC Rocky Mount Distribution Center General Manager Bill Stanulis (source: US EPA Greenhouse Gas

further stated, "We will continue to work closely with USDOL on any recommendations they may have to improve our quality and controls."

In addition to the USDOL audit, the Social Security Administration reviewed the business process for secured Social Security number verifications and also found no significant weaknesses with security of this information. However, the Social Security Administration did recommend the DES include the SSA in their breach notification process, and also requested the DES purge SSA verification information from its systems on a regular basis to comply with the contract agreement between the DES and SSA.

Finally, the U.S. Treasury Department reviewed the business processes implemented to secure federal tax information because federal tax refunds are now being used to recover overpayment of Unemployment Insurance benefits. To ensure that DES met federal regulations to handle Federal Tax Information, the IRS required DES to submit its controls implemented to secure FTI by June 30, 2013. DES submitted the required Safeguard Activity Report and Inspections in a timely manner to the IRS. The IRS reviewed the Division's Safeguard Activity Report and found that DES had no outstanding review findings. They also noted that no Corrective Action Plan was required.

As a result, DES is allowed to continue participating in the Treasury Offset Program, which allowed DES to collect more than \$11,000,000 in UI benefit overpayments since January 2013 from federal tax refunds.

"Protecting claimant and employer information is a top priority," said Folwell. "In order to meet the expectations of our customers, we must ensure that the proper controls are in place. The audit by the SSA and the IRS certifies that DES is adequately protecting both Social Security numbers and FTI.

"In addition to these audits, the U.S. Office of Inspector General and the N.C. Office of the State Auditor are in the process of completing their audits. We not only welcome their presence, but are encouraged by the opportunity to show continued improvement."

- High efficiency HVAC units and LED lighting installed in all dock lights.
- A "white roof" which reduces cooling costs
- A community garden created for employees to grow fresh vegetables for local food banks
- Sheep on the premises that have reduced the need for gas-powered lawn mowers

"QVC is a valued retailer and is a huge asset to the Rocky Mount region," said Governor Pat McCrory. "They continue to increase their value to the area by exploring and implementing sustainable energy options. We applaud their leadership and appreciate their contribution to the community."

QVC Rocky Mount has been in Edgecombe County since 2000 and currently employs more than 1,000 people. During peak seasons, the company employs as many as 1,500 people.
