Subject: Reallotment of Workforce Innovation and Opportunity Act (WIOA) Title I Formula-Allotted Funds for Dislocated Worker Activities for Program Year (PY 2016)

**Purpose:** 

To adjust funding levels of PY 2016 allotments for the Dislocated Worker program and to rescind DWS Policy Statement Number 7-2016, Local Workforce Innovation and Opportunity Act (WIOA) Workforce Development Program 2016 Allocations.

**Background:** 

The U.S. Department of Labor released Workforce Innovation and Opportunity Act Allotments for PY 2016 (July 1, 2016 – June 30, 2017) for Youth, Adult, and Dislocated Worker Activities in Training and Imployment Guidance Letter (TEGL) No. 17-15. The state allotments are based on funds appropriated to the U.S. Department of Labor by the United States Congress through the Consolidated Appropriations Act, 2016.

Recently, TEGL No. 24.16 increased state funding levels, due to unobligated PY 2015 Dislocated Worker funds exceeding 20 percent of the allotment for that program year, to eligible states as required by WIOA Section 132(c).

This Policy Statement adjusts funding levels of PY 2016 allotments for the Dislocated Worker program for North Carolina.

The attached charts reflect the adjustment of funds for the October portions of the Program Year 2016 Local Area Dislocated Worker allocations.

Also, included for convenience, are the original charts for Adult and Youth allocations, which have remained unchanged.

**Action:** 

The attached allocation charts are to be used for planning and operating Program Year 2016 Workforce Innovation and Opportunity Act programs under the PY 2016 Local Area Plans.

Local Workforce Development Boards will be allocated the funds through the Workforce Information System Enterprise (WISE) system when received by the Division.
